CAEP- Status and Action Plans

- Council meeting with CAEP in October- should hear final results very soon
- Currently 2 national accreditation bodies for Teacher education- CAEP only one nationally recognized.
 - 2016 CAEP mandate-show impact on student learning of alumni. In response:
 - Case Study data collection with alumni.
 - Alumni and employee surveys
 - Will continue to gather artifacts for this CAEP mandate.

Updates from USBE

Changes in licensure levels are going into effect: January 1, 2020

- USBE will discontinue ARL and APT as we know them
 - Students will have the option to go through higher education or school districts for teacher prep.
- Old multi-tiered licenses (level 1, level 2, level 3) discontinued and introduce three new licenses:
 - Associate: Preparing to be a teacher/working through program
 - Temporary/Proficiency based license
 - Good of 2 years with optional 1 year extension
 - Requirements: Background check, Praxis II scores/Content Major, Bachelor's degree or admitted to license program and entering student teaching. Teacher candidates going through school districts will also have 4 USBE modules to complete.
 - University Student teachers will be issued an Associate license prior to beginning student teaching.
 - USBE will work directly with Universities on issuing Associate licenses to our student teachers.
 - **Professional:** Completed a licensure program; successfully complete all licensure requirements upon recommendation
 - Must pass Pedagogy Performance Assessment (PPAT, edTPA, other)
 - University of Utah students who complete program requirements and pass PPAT will be recommended for Professional Teaching license.
 - o LEA license: Other
 - Not issued through Higher Education
- University of Utah students who complete licensure requirements and PPAT will be recommended for a Professional license.
- The support available through University programs, and same standard requirements for professional licensure, may incentivize students to stay and complete traditional licensure programs.
- School Districts may reach out to Universities/Colleges to create partnership packages for students.

Performance Assessments Effective January 1, 2020

- Pedagogy standards will be set by USBE
 - Anyone seeking licensure (prepared through districts or higher education) will be held to same standards. This will be a firm requirement in order to move from the associate license to the professional license.
- Colleges/Universities will have freedom to choose own Performance Assessment tool to document meeting these standards with the understanding accreditation and related requirements must be met.
- Options:
 - PPAT (ETS)
 - Anchor artifacts across different courses to create an electronic portfolio
 - Portfolio reviewed by third party
 - https://www.ets.org/ppa/test-takers/teachers/about
 - edTPA (Pearson)
 - UVU currently uses this tool
 - Anchor artifacts across different courses to create an electronic portfolio
 - Portfolio reviewed by third party
 - o Other
 - COE created tool will be too time consuming to develop and validate.
 - 3rd party review more objective
- Students admitted after Jan 1, 2020 will need to adhere to these standards. They will need to pass assessment tool in order to be recommended for professional licensure.
 - Pilot Program this year of 10 students completing the PPAT
 - o Everyone graduating/completing licensure Spring 2021 will complete the PPAT

- K-3 Updates
 - USBE approved new K-3 licensure program.
